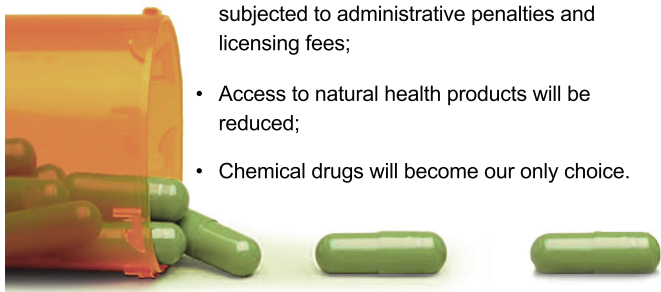
WHY YOU SHOULD BE OUTRAGED

WHAT DOES THIS MEAN TO THE CONSUMER?

- The Natural Health Product Regulations will be phased out and replaced;
 - Natural health products will be regulated under the same regulations as chemical drugs;
 - The draconian enforcement powers the government promised would not be applied to natural health products will be applied to NHP's;
 - The health conditions natural health products can be used for, will be further curtailed;
 - Censorship of the truth about NHP's by Health Canada.
- The natural health community will be subjected to administrative penalties and licensing fees;
 - Access to natural health products will be reduced;
 - Chemical drugs will become our only choice.



THROWING OUT THE NATURAL HEALTH PRODUCT REGULATIONS JUST AS THE NATURAL HEALTH COMMUNITY HAS COMPLIED WITH THEM

The Natural Health Product Regulations were drafted specifically for natural products in response to the recommendations of the Standing Committee on Health. It has been only 15 years since the Regulations came into force. It has taken almost all of those 15 years for the natural health community to come into compliance with the new Regulations.

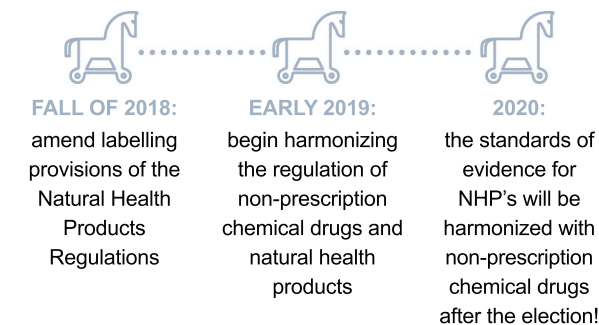
THE SECRECY OF THE PROPOSALS: THE DEVIL IS IN THE DETAILS AND DETAILS ARE NOT GIVEN
