As a voter residing in the [redacted] postal code, I am demanding that you pass the **Charter of Health Freedom (Health Charter)** into law (charterofhealthfreedom.org).

1. The **Health Charter** codifies the health rights our Courts say we have.
2. The **Health Charter** requires a balanced risk analysis in the regulation of natural remedies. A balanced risk analysis is required to get the best health outcomes.
3. The **Health Charter** creates the Ministry of Wellness to protect and promote our access to natural remedies.
4. The **Health Charter** frees us from the dangerous drug model. Under the drug model it is illegal to treat serious health conditions with anything but novel chemicals. This does not lead to good health outcomes. The monopolies of the pharmaceutical companies must end.
5. The **Health Charter** will save lives. Health Canada restricts our access to natural remedies which has led to death and suffering. Canadians will share during the Charter Tour that they are only alive because of natural remedies. They are sharing this truth to drive home to you that our access to natural remedies is a matter of life and death. Enough is enough!
6. The **Health Charter** will end the censorship of truthful health information. The law needs to state that all information about a drug, chemical or natural, must be shared with the public. Canadians need truthful health information to make good health decisions.
7. The **Health Charter** will put Canadian NHPs first! Canadians Producers will have a fair regulatory environment. This will lower prices for Canadians and protect our Canadian businesses.

The Health Charter is the most important health initiative in our lifetime. Do your part. Make the Health Charter law.


